Approval of stand construction

Approval of stand construction is required if:

- the building height exceeds 3.50 m in hall 1
- under the gallery
- the floor space exceeds 30 sqm
- stands have closed ceilings
- for special structures

Examination of structures requiring approval

Before the trade fair start (Leadtime: 9 weeks) the following documents are required for approval in german language:

 dimensioned stand plans, with the ground planes and elevations shall be submitted either in digital form (one copy) or on paper (three copies)

Important information and guidelines for multi-storey stand and stands with accessible levels

- These stands require in any case approval of Landesmesse Stuttgart GmbH/HINTE Expo- & Conference GmbH.
- The following documents must be submitted as PDF files in German language and no later than 9 weeks before the beginning of stand set-up:
 - a) Building specifications
 - b) Stand construction plans (ground plan, elevations, sectional views), larger-scale drawings of design details
 - c) On submission of a duly stamped official inspection logbook/ type qualification, the above items a) and b) shall not be required

- For multi-storey exhibition stands, a proof of structural stability is required. In principle, the test engineer commissioned to perform this work shall come from Baden-Württemberg. A test static engineer, who is commissioned to perform a static test, may also, by way of exception, come from a German federal state other than Baden-Württemberg. The work shall then be accepted on-site by a test engineer who is recognised in Baden-Württemberg and who shall provide an acceptance certificate. This certificate must be available on the stand for presentation. Please see 4.2. of the Technical Guidelines of Landesmesse Stuttgart GmbH.
- The exhibitor/stand builders shall provide information regarding the engineer commissioned to perform this work on-site.
- You will find the approval note(s) of Landesmesse Stuttgart GmbH in the stand design plan(s).

The Technical Guidelines of Landesmesse Stuttgart GmbH must be observed.
